- 5. The tender should be submitted in two tier system, 1. Technical Bid and 2. Financial Bid. The Technical Bid should be submitted in a sealed envelope super scribed as 'Technical Bid', and Financial Bid should be submitted in a separate sealed envelope super scribed as 'Financial bid'.
