2. The Tender document can be purchased from the office of JTDCL on any working day by paying Rs.1120/- inclusive of GST in the form of DD/Cash payable at Ranchi in favour of Jharkhand Tourism development Corporation Limited as document fee. Bidder can also download the Tender document from the website www.jharkhandtourism.gov.in however in case of downloading of the bid documents; bidder(s) have to submit the said demand draft (nonrefundable) along with their Bid.

3. Place of purchase, submission of tender document and opening of technical and financial bid is the office of Jharkhand Tourism development Corporation Ltd, 5, Mahatma Gandhi Marg, Ranchi-834001.
4. The tenderer shall submit the highest financial bid for the condemned vehicles, over and above to the minimum market price fixed for the vehicles prescribed in the above table.
5. The tender should be submitted in two tier system, 1. Technical Bid and 2. Financial Bid. The Technical Bid should be submitted in a sealed envelope super scribed as '**Technical Bid**', and Financial Bid should be submitted in a separate sealed envelope super scribed as '**Financial bid**'. Both these envelopes should be submitted in a larger envelope super scribed as "**TENDER FOR THE CONDEMNED VEHICLES.**"
6. **The technical bid shall consist of the following:**
 - a. The individual/firm/agency with proof of attested documents such as Aadhar card/Voter Identity Card/Passport for individual and Registration Certificate/Bank statement of past three months/GSTN registration certificate in case of firm/agency.
 - b. Earnest money deposit of Rupees 25,000/- (Rupees Twenty Five Only) will have to be submitted along with the tender in the shape of Demand Draft drawn in favour of Jharkhand

Tourism Development Corporation Limited payable at Ranchi issued by any scheduled bank in India.

- c. Bid received without EMD and document fee will not be considered and will be rejected.
- d. The financial bid shall be opened for tenderer who will qualify the technical bid.

7. Financial Bid:

- a. The tenderer shall submit the Financial bid for the condemned vehicles, subject to the minimum market price fixed for the vehicles prescribed in the above table in the attached **PROFORMA** only as **Annexure- I**.
 - b. The one tenderer can submit his/their bid for maximum three condemned vehicles on as is and where is basis.
 - c. If the offered rate is below the minimum market price the tender will be rejected.
- 8.** The successful bidder will be required to deposit the bid amount in shape of demand draft issued by any scheduled bank in favour of Jharkhand Tourism development Corporation Limited payable at Ranchi within three working days of the acceptance of the bid.
- 9.** The EMD of the successful bidder will be released only after the deposit of sale proceeds. EMD will be forfeited, if bidder fails to honour the bid.
- 10.** The sold vehicle will be removed from the JTDCL's office by the successful bidder within two days of depositing the bidding amount at their own expenses.
- 11.** The vehicle will be disposed of on as is where is basis is and no guarantee for its worthiness or quality will be given by this office.
- 12.** The bidder will not be allowed to withdraw his/their bid, failing which his/their EMD will be forfeited.
- 13.** The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/their name at his/their own cost expeditiously. JTDCL will not be responsible for any lapse on his/their part in this regard.
- 14.** Word "Tenderer" written in tender Document shall be read as the individual/firm/agency. The list of documents for satisfying the individual/firm/agency is described in clause 06(a).
- 15.** Jharkhand Tourism Development Corporation Limited reserves the right to reject any or all proposals and annul the tender process at any time without assigning any reason whatsoever.
