The Jharkhand Tourism Development Corporation Limited (JTDCL), Government of Jharkhand (GoJ) undertaking intends to invite Tender for Renting out shops at Birsa Vihar Shopping Premises, Ranchi, Jharkhand, on monthly rental.

Jharkhand Tourism Development Corporation Ltd. (JTDCL) invites tender to rent out its 06 (Six) shops at Ground Floor and First Floor of Birsa Vihar Market Complex, Ranchi on as is and where is basis, on monthly rental for a period of 5 (Five) years extendable for another period of 5(Five) years, subject to performance of the successful tenderer.

In order to participate in the Selection Process, the Bidder's should be a single business entity (the "Single Business Entity"). The term Bidder used herein would apply to a Single Business Entity.

A Single Business Entity shall mean a company incorporated under Companies Act, 1956/2013 or a sole proprietorship firm or a sole proprietorship firm registered under the Proprietorship Act, 1908 or a partnership firm registered under the Indian Partnership Act, 1932 or a Limited Liability Partnership Firm registered under Limited Liability Partnership Act, 2008.

The tender should be submitted in two tier system, 1. Technical Bid and 2. Financial Bid. The Technical Bid should be submitted in a sealed envelope superscribed as 'Technical Bid', and Financial Bid should be submitted in a separate sealed envelope superscribed as 'Financial bid'. Both these envelopes should be submitted in a larger envelope super scribed as "Tender for Shop No......at Birsa Vihar Market Complex".

The technical bid shall consist of the following:

- a. A detail statement of the proposed use of space (certain activities/ uses are prohibited like opening of butcher shop, wine shop, garage, etc.);
- b. A note specifying the constitution of the firm/company/agency and the documents relating thereto. The list of documents for satisfying the constitution of the firm/company/agency is hereunder and should be submitted along with:
 - i. Incorporation certificate
 - ii. Registration certificate of the firm/agency
 - iii. GSTN Certificate
 - iv. Copy of PAN
 - v. Bank Statement
 - vi. Character certificate issued by S.P./D.C. office.
 - vii. Proof of bid document cost paid or DD of equivalent amount of Rs. 1,770/- in favour of Jharkhand Tourism Development Corporation Ltd. Payable at Ranchi.
- c. Earnest money deposit of Rs. 50,000/- (Rupees Fifty Thousand Only) will have to be submitted along with the tender in the shape of Demand Draft drawn in favour of Jharkhand Tourism Development Corporation Limited payable at Ranchi;
- d. The tender received without document fee and EMD will not be considered and rejected.

Financial Bid:

The tenderer shall submit the Financial bid for whole portion of space of one shop, subject to base rent of minimum per Sq.Ft., prescribed in table per month in the above format.

Note:

- 1. The financial bid shall be opened for tenderer who will qualify the technical bid.
- 2. The Last Date and time of receipt of Tender will be 01/08/2023 at 11:30 AM, and
- 3. the technical & financial bid will be opened on 01/08/2023 at 12:00 Noon or thereafter
- 4. the date of opening of financial bid will be intimated further
- 5. if the offered rate is below the base price the tender will be rejected.
- 6. The successful tenderer will have to enter into an agreement with JTDC Ltd. spelling out the terms and conditions including to increase the rent @ 5% on each succeeding years and keep the security deposit equivalent to the six months' rent with the JTDC Ltd;
- 7. The applicable taxes (GST) shall be charged over and above the monthly rent.
- 8. For Shop No.- 19, preference will be given to the agency working in the Tourism sector.
- 9. The undersigned reserves the right to reject any or all proposals and annul the tender process at any time without assigning any reason whatsoever.
- 10. Word "Tenderer/Agency" written in tender Document shall be read as the Firm/Company/Agency.
- 11. JTDCL may at its sole discretion and at any time during the evaluation of Proposal, disqualify any bidder, if the bidder has:
 - I. Submitted the Bid after the response deadline;
 - II. Made misleading or false representations in the forms, statements and attachments submitted in proof of the eligibility requirements;
 - III. Failed to provide clarifications related thereto, when sought;
 - IV. Declared ineligible by the Government of Jharkhand/India for corrupt and fraudulent practices or blacklisted;
 - V. Submitted a proposal with price adjustment/variation provision.
 - VI. Or for any other reasons.
- 12. Subletting not allowed. Criminal action will be taken if found violating this clause.
